In reference to the above mentioned memo, the undersigned is directed to say that Sri Tapan Karmakar, Ex- Leader, Bhatar Fire Station, Burdwan Division, West Bengal Fire and Emergency Services has submitted a medical reimbursement claim to the amount of **Rs.24,269/- (Rupees Twenty Four Thousand Two Hundred Sixty Nine )** only for OPD treatment in connection with '**Cancer Radiotherapy**' of his own from 12.08.2021 to 30.08.2021 at 'the Tata Medical Centre, 14, MAR, (EW), Newtown, Kolkata- 700160 (Code No.0411084) under the purview of WBHS-2014. 3.The Divisional Fire Officer, Burdwan Division, West Bengal Fire & Emergency Services, will act as Drawing and Disbursing Officer in respect of the expenditure sanctioned herein.

The charge will be debited from the head of Account "2071-Pension and Other Retirement Benefits-01-Civil-800-Other Expenditure -002-Re-imbusement of Medical Expenses-V-12-Medical Reimbursement, under West Bengal Health Scheme, 2014" under demand No.18, from the budget of the current financial Year 2022-2023.


