## **NOTIFICATION**

The present practice in the meeting of the Technical Expert Committee (TEC) under the West Bengal Fire & Emergency Services at Durgapur, Kharagpur, Kolkata and Siliguri is that the applicants have the option to attend or to depute their architect in the TEC meeting whenever their application is taken up there.

The Governor is pleased to direct that henceforth the applicants are not required to attend the TEC meetings any more. The applicants shall be required to send the set of Plans and Structural Drawings for which Fire Safety Recommendation / Fire Safety Certificate / Renewal of Fire Safety Certificate is required, in duplicate, either by post or by courier after submission of their online application along with a self-addressed envelope with the requisite stamps, so that a copy of the Plans and structural drawings may be returned after disposal of their case. In case the applicants so desire they may be represented by their architect for offering clarifications if any required by the TEC members. Member Secretary of concerned TEC is directed to return by post/courier as the case may be, the duly initialed plan drawings within 3 (three) working days of signature of TEC minutes by the Chairman of the TEC.
