NOTIFICATION


Whereas, the Department of Fire & Emergency Services runs the citizen centric platform for acceptance of applications for Fire Safety Recommendation (FSR), Revised Fire Safety Recommendation (RFSR), Fire Safety Certificate (FSC), Renewal of Fire Safety Certificate (RFSC), Grant of Fire Licenses (GFL), Renewal of Fire Safety Licenses (RFSL) and the recently added Self-Certification for small and low risk business units;

And Whereas, for Fire License applications, FSR/FSC or Self-Certification is a pre-requisite in the eDistrict 2.0 portal;

And Whereas, for Ease of Doing Business (EoDB), it was decided in a meeting between the Department of Fire & Emergency Services and the Department of MSME&T that one more provision would be made available for the citizens in case of non-availability of FSR/FSC or Self-Certification so that no citizen is denied of making the applications.

Now, therefore, the Governor is pleased to state that in the case of non-availability of FSR/FSC or Self-Certification another option would be made available to the citizen for applying for Fire License or its renewal. Once the concerned Inspector gets such application, he will check the application and visit the unit and if needed he will sensitize the applicant and guide him/her for applying for FSR/FSC or Self-Certification, as the case may be.

This is issued in the interest of public service with immediate effect.


