Whereas, **West Bengal Fire and Emergency Services** Department has approached to WRID Department to consider bringing all existing and upcoming and/ or proposed '**Fire Stations**' under GoWB, which are extracting groundwater through Tube wells fitted with submersible pump to combat unfortunate fire incidence or emergency situation under exempted category and to ensure the uninterrupted supply of water for fire fighting purposes and related usage,

Whereas, the matter has been examined by SWID and recommended to WRID Department to consider bringing '**Fire Stations**' under the **WBF&ES Deptt.**, drawing Ground Water only for unfortunate fire incidence or emergency situation under exempted category ,

And

Whereas, the competent authority in the State Government has accepted the recommendation in terms of earlier Memo 130-SWID dated 08.09/2011 of WRID&D in the public interest,

Now therefore, in exercise of power vested vide **Section 7 (1) of WBGWR Act, 2005**, the Governor is hereby pleased to exempt such category from the purview of Permit with intimation before boring of Tube-well, in each occasion.

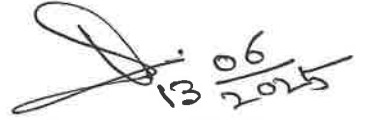

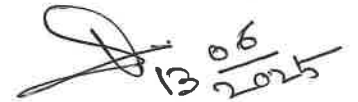

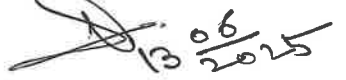
