ORDER

Whereas the validity period of Fire Safety Certificate (FSC) or No Objection Certificate issued in favour of various classes of buildings under the provisions of the West Bengal Fire Services Act, 1950 and the rules framed there under, is usually 3 (three) years;

And whereas the State Government in the Department of Fire & Emergency Services has been considering to extend the validity of fire NOCs beyond 3 years for the sake of *Ease of Doing Business*;

Now, after careful consideration of the aforesaid matter, it has been decided that the validity of FSCs or fire NOCs issued under the provisions of the West Bengal Fire Services Act, 1950 and the rules framed there under, in favour of the government primary schools shall be extended upto 5 (five) years.

This order is issued in the interest of public services with immediate effect.
