Subject: Publication of provisional shortlist of companies towards engagement as Third Party Agencies/ Licensed Agency and invitation for participation in Reverse Bid Procedure.

Subsequently, 16 (sixteen) companies have been provisionally shortlisted in the procedure for Selection as Third Party Agencies/ Licensed Agencies as given in the **Annexure -I**. However, the companies listed in **Annexure-II** may also participate in such bids invited by this Department **in future**, if they fulfil the essential conditions in the upcoming events in this regard, as may be endorsed by this Department.

A Reverse bid, in physical mode will be held in this regard at 1:00 pm on 22nd December, 2025 in the Conference Hall (3rd Floor) at New Town Fire Station Building, Kolkata – 700156. The companies listed in Annexure-I are hereby invited to participate in the Reverse Bid process. A maximum of 02 (two) representatives may be sent by the listed (Annexure-I) companies for such participation with necessary documents. Videography of the entire procedure of physical/offline Reverse Bid will be done by this Department.

The finally shortlisted companies shall have to deposit an Earnest Money/Licence fee, quantum of which will be informed later.

It is further mentioned that an Agreement is to be signed by the shortlisted companies with the Directorate of Fire & Emergency Services, WB during the Selection Procedure in prescribed format. The date of signing of such agreement would be notified later.


Login credentials will be created in the name of authorized person of each Selected Company, who will be imparted training / handholding by the Department, in due course.


